He stated that at this time we can only accept or reject what they have written. He further clarified that we cannot make any additional changes, grammatical or otherwise, to what they have given us.
  - b) Discuss our response to the Board of Selectmen -

After discussing each of the three Board of Selectmen's proposed changes, motions were made to accept or reject.

MOTION: To reject the changes proposed by the Board of Selectmen in Section 805.

Commissioner Boucher liked the Selectmen's version better than what the Commission proposed. He felt it gave guidance. Chairman Calsetta read the version submitted by the Board of Selectmen and a vote followed.

6) **Commissioners Comments –** Chairman Calsetta stated that the Board of Selectmen will now have to decide whether or not to have a referendum to approve the changes to the Charter or put it on the Ballot this fall.

Commissioner Bill Hamel thanked the other Commissioners for their work on the Charter Commission. He added that although the job seemed minor at times, it is our right and you've all done a noble job. Chairman Calsetta agreed.
