

## BOARD OF ASSESSMENT APPEALS

Minutes of the September 29, 2022 Regular Meeting

**CALL TO ORDER:** Chairwoman, Lori Quagliaroli called this Board of Assessment Appeals meeting to order at 6:30 p.m.

MEMBERS PRESENT: Chairwoman Lori Quagliaroli, Paul Riedi and Mark Whitten, Jr.

MINUTES OF PREVIOUS MEETING APPROVAL: April 21, 2022 & September 15, 2022 Mark Whiten, Jr. moved to accept the Board of Assessment Appeals Minutes from April 21, 2022 and September 15, 2022 as written. Paul Riedi seconded this motion. All were in favor and this motion carried.

ADDED AGENDA ITEMS: There were no added agenda items.

**HEARING OF APPEALS/DECISIONS:** The board deliberated on motor vehicle appeals heard during the September 15, 2022 meeting.

- Joshua Miskin, 103 Old County Road-2014 Chevy Equinox: The board agreed with the
  calculated assessment of the Assessor decreasing taxes of this vehicle by \$17.56. Paul
  Riedi moved to decrease the taxes of Joshua Miskin of 103 Old County Road on his
  2014 Chevy by \$17.56. Mark Whitten, Jr. seconded this motion. There was no
  discussion. All were in favor and this motion carried.
- Sara Ackley, previously represented by Joshua Miskin, 103 Old County Road-2008
   Honda Odyssey: The board agreed with the calculated assessment of the Assessor
   decreasing taxes of this vehicle by \$8.08. Paul Riedi moved to decrease the taxes of Sara
   Ackley of 103 Old County Road on her 2008 Honda Odyssey by \$8.08. Mark Whitten,
   Jr. seconded this motion. There was no discussion. All were in favor and this motion
   carried.
- Victor Pomerleau, 14 Pine Drive-2005 Ferrari: After brief discussion, the board agreed that 70% of low retail value would calculate out to be \$77,980.00 for this vehicle. Paul Riedi made a motion to revise Victor Pomerleau of 14 Pine Drive-2005 Ferrari valuation from \$119,000.00 to \$77,980.00. Mark Whitten seconded this motion. There was no discussion. All were in favor and this motion carried.

PUBLIC INPUT: There was no public input.

MEMBER DISCUSSION AND CONCERNS: There was no member discussion or concerns.

At this point in the meeting, Paul Riedi moved to adjourn at 6:45 p.m. and this motion was seconded by Mark Whitten. All were in favor. All were in favor and this motion carried.

**ADJOURNMENT:** There being no further discussion or information to come before the Board of Assessment Appeals, a motion to adjourn the meeting at 6:50 p.m. was made by Mark Whitten, Jr. and Paul Riedi seconded the motion. All were in favor and this meeting adjourned.
