A public hearing of the electors and citizens qualified to vote in town meetings of the Town of Windsor Locks, Connecticut, will be held in the meeting room of the Town Office Building, 50 Church Street in the Town of Windsor Locks, Connecticut, on Tuesday, January 2, 2024, at 7:00 p.m.

The public hearing shall be held for consideration of amending the Senior Center project and the Police Headquarters project to increase the appropriations and borrowing authorizations for each.

The Special Town Meeting of the electors and citizens qualified to vote in town meetings of the Town of Windsor Locks, Connecticut, will be held in the meeting room of the Town Office Building, 50 Church Street in the Town of Windsor Locks, Connecticut, on Tuesday, January 2, 2024, at 7:30 p.m.

The town meeting shall be held for the following purposes:

1. To consider a resolution to amend the resolution approved by voters on March 3, 2022 entitled “RESOLUTION APPROPRIATING \$13,490,000 FOR THE DESIGN AND CONSTRUCTION OF THE NEW SENIOR CENTER PROJECT AND THE ACQUISITION OF PARCELS KNOWN AS 491 AND 519 SPRING STREET, WINDSOR LOCKS; AND AUTHORIZING THE ISSUE OF BONDS AND NOTES IN THE SAME AMOUNT TO FINANCE THE APPROPRIATION” increasing the appropriation and borrowing authorization by an additional \$780,000 (thereby increasing the appropriation and borrowing authorization to an aggregate \$14,270,000) for the design and construction of a new Senior Center.

2. To consider a resolution to amend the resolution approved by voters on March 3, 2022 entitled “RESOLUTION APPROPRIATING \$15,150,000 FOR THE DESIGN AND CONSTRUCTION OF THE NEW POLICE HEADQUARTERS PROJECT AND THE ACQUISITION OF PARCELS KNOWN AS 491 AND 519 SPRING STREET, WINDSOR LOCKS; AND AUTHORIZING THE ISSUE OF BONDS AND NOTES IN THE SAME AMOUNT TO FINANCE THE APPROPRIATION” increasing the appropriation and borrowing authorization by an additional \$3,980,000 (thereby increasing the appropriation and borrowing authorization to an aggregate \$19,130,000) for the design and construction of a new Police Headquarters.

The aforesaid resolutions presented will be placed on the paper ballots or voting machines under the following headings:






Voters approving a resolution will vote “Yes” and those opposing said resolution will vote “No.”
