APPROVAL OF AUGUST 6, 2024 REGULAR MEETING MINUTES:

Selectman Savino moved to approve the August 6, 2024 Regular Meeting Minutes. Selectman Cannon seconded the motion. All in favor. Motion carried.

OLD BUSINESS:

a. Building Committee Update:

Selectman Storms stated that the Selectmen signed the beam last week and took a tour of the facilities. He further stated that the project appears to be progressing, is on target and still within budget.

b. Main Street Update:

Selectman Storms stated that progress is continuing on Main Street. He noted that some of the contractors are running into delays and a bit behind schedule.

Public Works Director Phil Sissick provided an update on the progress of the old Train Station and the bid package.

Selectman Storms stated that there is another amendment request to the engineering contract for an additional \$5,000. Further, he explained the reason for the request and asked for authorization to sign the amendment.

Selectman Savino moved to authorize an additional \$5,000.00 to Fuss & O'Neill for engineering and design work. Selectman Savino seconded. All in favor. Motion passed.

Selectman Storms and Phil Sissick provided further updates regarding Main Street.

c. Roads Update:

Phil Sissick provided an overview of the capital projects involving roads. Interim Finance Director Jason Lathrop commented on the financial aspect.

TAX REFUNDS:

Selectman Cannon moved to approve the current year refund in the amount of \$128.65 and the prior year tax refund in the amount of \$42.26 for a total of \$170.91. Selectman Savino seconded the motion. All in favor. Motion carried. (Schedule A attached)

As a matter of clarification, he stated that at the last Board of Selectmen Meeting, Roger Susaya was appointed to a 3-year term to fill the vacancy on the Planning and Zoning Commission. The letter sent to Mr. Susaya did not specifically state that it was for an alternate position. A clarification letter has been sent.
