# BOARD OF SELECTMEN Tuesday, September 17, 2024

#### In-Person and via Zoom Teleconference

SELECTMEN PRESENT: Scott Storms, Jon Savino and James Cannon

ALSO PRESENT: Town Attorney Carl Landolina, Peggy Sayers and Members of the Public

ATTENDING REMOTELY: Eric Marsh and Members of the Public

#### **CALL TO ORDER:**

First Selectman Scott Storms called the meeting to order at 6:00 p.m.

#### PLEDGE OF ALLEGIANCE:

The Pledge of Allegiance was observed

Selectman Storms stated that there would be no Executive Session at tonight's meeting as it was no longer necessary.

#### APPROVAL OF AUGUST 20, 2024 REGULAR MEETING MINUTES:

Selectman Storms noted the August 20, 2024 meeting was a Special Meeting and asked the motion to indicate that.

Selectman Savino moved to approve the Special Meeting Minutes for August 20, 2024 Minutes. Selectman Cannon seconded the motion. All in favor. Motion carried.

#### **CORRESPONDENCE:**

Selectman Storms stated that he has received correspondence relating to traffic issues on Main Street and Old County Road; he noted the need for people to drive more carefully, particularly in those areas where construction is going on.

He also stated that he received an email this afternoon regarding people passing school buses. He noted that, although that isn't under his authority, it is something that should be taken very seriously, is illegal and comes with fines and the possibility of jail time.

## **OLD BUSINESS:**

#### a. Building Committee Update:

Selectman Storms stated that the project is on target, roofs are going up and soon they will be working inside. He also said they are within the balances under the budget.

# b. Main Street Update:

Selectman Storms stated that they've spoken with the project manager about some of the items of concern, including the exit from CVS onto Main Street and the closure of Church Street at Main Street. He noted that something needs to be done to change the appearance of the green at the end of Church Street before the maintenance of the area is turned over to the Town. He further stated that they are coordinating work on the historic train station with the State.

He explained that the Town is also slated for consideration of a CIF Round 5 Grant for infrastructure under Main Street.

# c. Amended Brownfield Agreement:

Selectman Storms explained that this is an Amendment to the Brownfield Grant that was received in June, 2024 for the Brownfield Assessment of the Trinity project on Main Street.

## d. BOF Meeting Report:

Selectman Storms stated that he and the Public Works Director met with the Board of Finance last week and provided the roads and roofs updates.

# e. Ordinances – Citation and Hearing, Nuisance and Blight, Streets and Sidewalks, Citation for Zoning Violations, Wetland Violations Citations

Town Attorney Carl Landolina explained the proposed changes/amendments to existing ordinances and presented the new citation proposals. During discussion, other changes were proposed by the Board of Selectmen.

#### **NEW BUSINESS:**

## a. Review Employee Handbook:

Selectman Storms asked the Selectmen to review the handbook for suggestions for an update and to forward those suggestions to him for consideration. He explained that he has requested that Department Heads do the same.

#### b. Set Annual Ordinance Town Meeting:

Selectman Storms stated that Attorney Landolina has prepared the resolution to schedule a Public Hearing and Town Meeting regarding the revised Ordinances and proposed Citations that were presented during the meeting tonight.

Selectman Savino read the Resolution\* into the record. Selectman Cannon seconded the motion. All in favor. Motion carried.

#### c. SOC Grant Agreement for SLFRF - Registrars:

Selectman Storms stated that the grant is for monies the State has allowed for early voting on the primary. He further stated that the funding for the November election early voting will be paid from Town funds.

There were no objections from the Board regarding Selectman Storms signing the application.

#### d. SOC Covid Fiscal Recovery Fund Agreement - CONA:

Selectman Storms stated that the grant is regarding surplus State ARPA funds. He further stated that the money is proposed to be spent on furniture and equipment for outside activities at the new Senior Center.

There were no objections from the Board regarding Selectman Storms signing the application.

Selectman Storms asked for a motion to encompass the above two grants:

Selectman Savino moved to approve the SOC Grant Agreement for the Registrar of Voters and the Senior Center under CONA. Selectman Cannon seconded the motion. All in favor. Motion carried.

#### **TAX REFUNDS:**

Selectman Cannon moved to approve the prior year refund in the amount of \$1,255.62 and the current year tax refund in the amount of \$5,410.46 for a total of \$6,666.08. Selectman Savino seconded the motion. All in favor. Motion carried. (Schedule A attached)

#### APPOINTMENTS, RE-APPOINTMENTS, RESIGNATIONS:

Selectman Storms stated that he received a resignation letter from Amy Montemerlo, a member of the Arts Council. Further, he thanked her for her service.

He also stated that he received a recommendation from the Democratic Town Committee for Mary Jane Perrier to the Inland Wetlands Commission as a full member. She is presently serving as an alternate.

Selectman Savino moved to appoint Mary Jane Perrier to the Inland Wetlands Commission as a full member on the recommendation of the Democratic Town Committee. Selectman Cannon seconded. All in favor. Motion carried.

Selectman Storms stated that he also received a recommendation from the Republican Town Committee.

Selectman Cannon moved to appoint Barbara Palmer to fill the Republican vacancy for EIDC for the term ending June 30, 2029. Selectman Savino seconded. All in favor. Motion carried.

He also stated that Trunk or Treat is on Tuesday, October 29th from 6:00 p.m. to 8:00 p.m. at WLHS. To register a vehicle for that event, please call the WL Youth Service Bureau.

Additionally, he noted that the Human Resource Director is encouraging employees to participate in a customer service training and take a Voluntary Customer Service Action Pledge.
