a. Building Committee Update:

Selectman Storms stated that the parking lots have been completed this week and the lights have been adjusted to stay in the direction they need to for a longer period of time. The cameras are being replaced with Al cameras to adjust the lights automatically as well. He further stated that work on the exterior of the Historic Train Station will be starting soon.

NEW BUSINESS:

a. Gas Distribution Easement:

Selectman Storms explained that this is the gas easement to Eversource Energy for the new Senior Center and Police Station.

Selectman Savino moved to approve the Gas Main Easement to Yankee Gas Services Company dba Eversource Energy for property at 519 Spring Street aka the new Police Station/Senior Center, and to authorize the First Selectman to sign all necessary documents.

b. Town Hall Holiday Schedule:
