# APPROVAL OF December 3, 2024 REGULAR MEETING MINUTES:

# Selectman Savino moved to approve the December 3rd Meeting Minutes. Selectman Cannon seconded the motion. All in favor. Motion carried.

## FINANCE REPORTS AND REQUESTS:

## a. Funding Waivers and Approvals

Interim Finance Director Jason Lathrop and Selectman Storms explained the reason for the request for a bid waiver from School Superintendent, Shawn Parkhurst, for the North Street School roof.

Selectman Cannon moved for a purchase waiver for the Town of Windsor Locks for the North Street School roof for \$858,700. Selectman Savino seconded the motion. All in favor. Motion carried.

#### **OLD BUSINESS:**

#### a. Building Committee Update:

Selectman Storms stated that the project is on path to completion, within budget, and on target for July, 2025 completion.

#### b. Main Street Update

Selectman Storms stated that the project is on target and more structural construction is occurring. He provided an update regarding other various projects being worked on on Main Street.

### c. ARPA Update – Public Hearing and Town Meeting 12/19

Selectman Storms reported that ARPA, the Board of Selectmen and the Board of Finance have approved the requests. The next step is a Public Hearing which is scheduled for 7:00 and a Town Meeting which is scheduled for 7:30 this Thursday, probably to be held in the gym to accommodate more seating.

### **NEW BUSINESS:**

## a. Facilities Use Discussion:

Selectman Storms stated that he is interested in hearing thoughts and beginning discussions after the New Year on how to proceed with the old Police Department and Senior Center buildings and houses owned by the Town on Chestnut Street, once the new buildings are open.

## TAX REFUNDS:

Selectman Cannon moved to approve the prior year in the amount of \$488.28 and the current year refund \$0 for total refunds of \$488.28. Selectman Savino seconded the motion. All in favor. Motion carried. (Schedule A attached)

Paul Wrabel, 33 Pershing Road – commented on the Church Street intersection on Main Street with the box. Selectman Storms clarified that that is the intersection with Spring Street.
